## COUNT 1

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, did unlawfully, intentionally, and with premeditation kill, Matthew Wilson, in violation of T.C.A. §39-13-202, a Class A Felony, and against the peace and dignity of the State of Tennessee.

## COUNT 2

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, did unlawfully, intentionally, and with premeditation kill, Courtney Rose, in violation of T.C.A. §39-13-202, a Class A Felony, and against the peace and dignity of the State of Tennessee.

## COUNT 3

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, did unlawfully, intentionally, and with premeditation kill, Adrianna Williams, in violation of T.C.A. §39-13-202, a Class A Felony, and against the peace and dignity of the State of Tennessee.

#### **COUNT 4**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, did unlawfully, intentionally, and with premeditation kill, Juvenile B.W., in violation of T.C.A. §39-13-202, a Class A Felony, and against the peace and dignity of the State of Tennessee.

#### **COUNT 5**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, and knowingly remove and confine, Juvenile W.W., a person under thirteen (13) years of age, so as to interfere substantially with Juvenile W.W.'s liberty, in violation of TCA 39-13-305, a Class A Felony, and against the peace and dignity of the State of Tennessee.

#### **COUNT 6**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, did unlawfully possess a firearm and has been convicted of a felony for a prior crime of violence, an Aggravated Robbery in Madison County Docket #14-CR-423, in violation of T.C.A. §39-17-1307, a Class B Felony, and against the peace and dignity of the State of Tennessee.

#### **COUNT 7**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, intentionally and knowingly employed a firearm during the commission of a dangerous felony, to wit: First Degree Murder as alleged in count one, a violation of T.C.A. 39-13-305, in violation of T.C.A. 39-17-1324, a Class C Felony, and against the peace and dignity of the State of Tennessee.

#### **COUNT 8**


THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, intentionally and knowingly employed a firearm during the commission of a dangerous felony, to wit: First Degree Murder as alleged in count two, a violation of T.C.A. 39-13-305, in violation of T.C.A. 39-17-1324, a Class C Felony, and against the peace and dignity of the State of Tennessee.

**COUNT 9**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, intentionally and knowingly employed a firearm during the commission of a dangerous felony, to wit: First Degree Murder as alleged in count three, a violation of T.C.A. 39-13-305, in violation of T.C.A. 39-17-1324, a Class C Felony, and against the peace and dignity of the State of Tennessee.

**COUNT 10**

THE GRAND JURORS of LAKE COUNTY, TENNESSEE, duly empaneled and sworn upon their oath, present that AUSTIN DRUMMOND, on or about July 29, 2025, in LAKE COUNTY, TENNESSEE, and before the finding of this indictment, intentionally and knowingly employed a firearm during the commission of a dangerous felony, to wit: First Degree Murder as alleged in count four, a violation of T.C.A. 39-13-305, in violation of T.C.A. 39-17-1324, a Class C Felony, and against the peace and dignity of the State of Tennessee.
